Dear customer,

We hereby inform you that the XL-200 devices software has been updated to SW version 2024.C04 issued on 21<sup>th</sup> November 2024.

Application software ver.2024.C04 is released to include new feature & addressed issues reported in previous ASW ver. 2023.C02.

### List of Changes in XL-200 Application software ver.2024.C04:

1) New features:

- Stirrer wash for carry over pair (COP) definition.
- For N! flag cut off change from 0 to -0.01 for absorbance.
- To capture fast reaction from the reaction curve of high value sample's reaction compared with the calibrator's reaction curve, sub. Check activated for default test.  
**Check is not for Open tests**  
Pre-Requisition for fast reaction check: Load default Erba tests & reaction check activation ENC, using parameter management tool, installed from software CD.
- ABS! Flag: Auto-Rerun with decrease sample Volume: instead of re-run same volume.

2) Improvement:

- Attached W\* flag to the results if reagent absent/ VOD/ Froth observed during reagent wash aspiration.

3) Corrective action:

- For a test with Cubic Spline curve, when sample OD is exact same as the highest calibrator OD then result should be calculated appropriately (Not 0).

4) Bugs fixed:

- Auto copy calibration is not getting applied to copied test.
- Blank flash message gets displayed after completion of auto maintenance activity when Russian language is selected.
